I waive all claims against any of the Released Parties for any injuries, drowning, death, damages, losses or claims, whether know or unknown, which arise during or result from my participation and travel that may be associated with The Three Rivers Fly Fishers Inc. activities and outings, regardless of whether or not caused in whole or in part by the negligence, ordinary negligence or other fault of any of the Released Parties.

I release and forever discharge the Released Parties from all such claims.

I agree to indemnify and hold the Released Parties harmless from all losses, liabilities, damages, costs or expenses (including but not limited to reasonable attorneys' fees and other litigation costs and expenses) incurred by any of the Released Parties as a result of any claims or suits that I (or anyone claiming by, under or through me) may bring against any of the Released Parties to recover for any losses, liabilities, injury, drowning, death, costs, damages, or expenses which arise during or result from my participation in The Three Rivers Fly Fishers Inc. activities and outings, regardless of whether or not caused in whole or in part by the negligence, ordinary negligence or any other fault of the Released Parties.
